

Prof.Dr. Umut Kalyoncu'nun Özgeçmişİ

Prof. Dr. Umut Kalyoncu Ocak 1976'da İzmir'in Bergama ilçesinde doğmuştur. Evli ve iki çocuk sahibidir. Umut Kalyoncu ilkokul ve ortaokulu Bergama'da okuduktan sonra Lise 1 ve 2 eğitimini Trabzon Yomra Fen Lisesinde tamamlamıştır. Bergama Lisesinden mezun olmuştur. 1992 yılında Hacettepe Üniversitesi Tıp Fakültesi Türkçe bölümünde eğitimine tıp başlamıştır. Bir yılı İngilizce hazırlığı üzere 7 yıllık tıp fakültesi eğitimini 1999 yılında bitirerek mezun olmuştur. 2000 yılında Hacettepe Üniversitesi Tıp fakültesi iç hastalıkları anabilim dalında asistanlık eğitimine başlamıştır. 2003-2004 yılları arasında başasistan olarak çalışmıştır. 2004 yılında Hacettepe üniversitesinde Romatoloji yan dalına başlamıştır. 2007 yılında romatoloji yan dal uzmanlığını almıştır. 2007-2010 yılları arasında Romatoloji bilim dalında uzman olarak çalışmıştır. 2010-2011 yılları arasında GATA'da askerliğini tamamlamıştır. 2011 yılında doçentlik unvanını almıştır. 2011-2012 yılları arasında Antakya devlet hastanesinde devlet hizmet yükümlülüğünü yerine getirmiştir. 2013 yılında Hacettepe Üniversitesi iç hastalıkları anabilim dalı, romatoloji bilim dalında öğretim üyesi olarak çalışmaya başlamıştır ve halen aynı bölümde çalışmalarına devam etmektedir.

Prof.Dr. Umut Kalyoncu 2007 yılında 4 ay süresince Fransa'da Paris Cochin hastanesinde romatoloji ve epidemiyoloji konularında gözlemci olarak bulunmuştur. 2015-2016 yılları arasında bir yıl süreyle Birleşik Devletlerin Maryland eyaletinde Johns Hopkins Üniversitesinde klinik Romatoloji bölümünde araştırmacı fellow olarak çalışmış ve post-doc'ını tamamlamıştır. Temel araştırma konusu psöriyatik artritdir. 2011 yılından itibaren uluslararası psöriyatik artrit cemiyeti olan GRAPPA'nın üyesidir. Hakemli dergilerde yayınlanmış 82 orijinal çalışması vardır. Web of Science veri tabanına göre 224 bilimsel çalışması bulunmaktadır. Bu çalışmalara Aralık 2017 itibariyle 1046 atıf yapılmıştır, h-skoru 15'dir. Türk İç Hastalıkları Derneği ve Türkiye Romatoloji Derneği üyesidir.

Prof. Umut Kalyoncu
